



To ensure the highest integrity is maintained in the use of the teachings provided during the classes and events conducted by the Modern Mystery School during its [MMS International Program in May 2026](#) (“Program”), this Program Attendance Agreement (“Agreement”) is entered into by and between the Modern Mystery School, having its principal offices at 41 International Boulevard, Toronto, Ontario, Canada, M9W 6H3 (on behalf of itself and its affiliate offices; collectively, “MMS”), and the undersigned student and attendee of the Program (“Student”) (each herein referred to individually as a “Party,” or collectively as the “Parties”), and is effective as of the date it is last executed (“Effective Date”).

MMS provides professional training, training materials, and applicable certification(s) related to advanced metaphysics, esotericism, and spirituality. The Parties have agreed that MMS will provide to the Student the foregoing. Therefore, in consideration for the commitments set forth below, the adequacy of which the parties hereby acknowledge, the Parties agree as follows.

## MENTAL HEALTH INFORMED CONSENT AND DISCLAIMER

**By signing this Agreement, the Student acknowledges and agrees that the teachings, healings, and tools he/she receives from attending any portion of the Program are not a substitute for psychiatric, medical, or psychological treatments. The Student also acknowledges that he/she is responsible for continuing any treatments (if any) prescribed by his/her psychologist, psychiatrist, medical doctor, or other healthcare provider, including but not limited to therapy and medications. The Student will not consult any Modern Mystery School practitioners, members, and/or teachers (in/from the U.S., Canada, or abroad) regarding mental health issues or physical health issues, as they are not mental or physical healthcare providers. By signing below, the Student acknowledges and agrees that his/her attendance of – and his/her receipt of any teachings or tools during – the Program does not create a healthcare provider/patient relationship as between the Student and any member of MMS.**

## PROGRAM PARTICIPATION TERMS

- 1) The Student acknowledges and agrees that the information he/she receives in this Program is solely for his/her personal use and benefit, including but not limited to personal joy and fulfilment, unless otherwise expressly agreed by the MMS in writing.
- 2) The Student represents and acknowledges that he/she is attending the Program of his/her own Free Will, and that he/she is of sound body and mind at the time of making this decision. The Student also fully acknowledges and agrees that he/she is free to leave the Program at any point in time.
- 3) The Student acknowledges and agrees that the instructional materials and teachings he/she receives in any and all classes he/she attends during the Program are provided to the Student under a limited personal use license, unless otherwise expressly allowed by MMS in writing. As such, if MMS suspects any breach of the terms of this Agreement by the Student, MMS may, in addition to other remedies as it may have and



without liability to the Student, suspend or revoke the aforesaid license. Upon any such revocation, the Student will cease all use of any and all such instructional materials and teachings, and shall, at the Student's sole expense, return to MMS (or destroy at its election) all copies of the instructional material in his/her possession.

4) The Student will not attempt to re-teach, replicate, reproduce, reformulate, transcribe, sell, resell, market, publish, license, sublicense, assign, distribute, or otherwise make available the information received and/or learned during this Program (or any summary or written derivative of such information) for anyone else, in any way, without MMS's prior written consent in each instance, which consent may be granted, denied, or revoked at MMS's sole discretion.

5) The Student will absolutely not audio record, photograph, or video record any portion of the Program without MMS's prior consent, which consent may be granted, denied, or revoked at MMS's sole discretion.

6) Although the tools and teachings of MMS are powerful, the Student acknowledges that (a) results are not guaranteed; (b) results may vary; and (c) any results are determined by the Student's own dedicated practices and diligence. THE STUDENT FURTHER ACKNOWLEDGES AND AGREES THAT THE TOOLS AND TEACHINGS PROVIDED TO THE STUDENT DURING THE PROGRAM ARE PROVIDED "AS IS" AND "AS AVAILABLE" WITHOUT ANY REPRESENTATIONS OR WARRANTIES OF ANY KIND, EXPRESS OR IMPLIED; THE MODERN MYSTERY SCHOOL SPECIFICALLY DISCLAIMS ALL REPRESENTATIONS, WARRANTIES, AND COVENANTS WITH RESPECT TO THE TOOLS AND TEACHINGS PROVIDED DURING THE PROGRAM INCLUDING WITHOUT LIMITATION, IMPLIED WARRANTIES OF MERCHANTABILITY, OF SATISFACTORY QUALITY OR FITNESS FOR A PARTICULAR PURPOSE.

7) This Agreement and any action related to it will be interpreted and construed in accordance with the laws of the Province of Ontario, Canada, without regard to conflict of law principles. In any action at law, in equity, or otherwise arising out of or related to the Student's negligence or willful misconduct under, or his/her breach of, the terms of this Agreement (such as an action taken by MMS to enforce its terms, which action is necessitated by the Student's act or omission), MMS shall be entitled to reasonable attorneys' fees and costs, in addition to any other relief to which MMS may be entitled.

8) The Student acknowledges and agrees that MMS may take photographs, video, and audio recordings of any part of the Program (collectively "Media") for any lawful business use (such as promotional use). By signing below, the Student provides his/her irrevocable consent to use any such Media which captures, visually or audibly, the Student's participation in the Program. The Student hereby releases MMS from any and all claims and liability under any legal theory regarding MMS's use of such Media.



9) The information the Student receives and/or learns in this Program shall be deemed a trade secret of or otherwise *proprietary* to MMS, and as such, Paragraph 4 above shall remain in effect until MMS expressly waives the Student's compliance with its provisions through a written waiver duly signed by an officer of MMS.

10) The Student's obligations under this Agreement shall survive until such time as MMS expressly and in writing waives the Student's compliance with its provisions. The Modern Mystery School's failure to enforce any provision of this Agreement shall neither be construed as a waiver of the provision, nor prevent MMS from enforcing any other provision of this Agreement.
